## Medical Education in Germany: Development of the National Competence Based Catalogue of Learning Objectives

The transition from a content-based curriculum to a competency-based curriculum in medical education [1] is internationally far advanced and an ongoing process in Germany. The current German Licensing Law for Physicians (ÄAppO) does not directly address "competence", but spells out clusters of learning objectives resembling the roles of physicians in practice as described in the CanMeds 2005 competency framework. To enhance the development of compentency-based curricula and assessment on a nation-wide platform, the German Association for Medical Education (GMA) in cooperation with the Association of German Medical Faculties (MFT) together with all stakeholders in Germany [2] developed a National Competency Based Catalogue of Learning Objectives (NKLM) in November 2009. The catalogue was passed by the assembly of German Medical Faculties in June 2015 and sent to all faculties [3]. The catalogue describes, based on the CanMeds framework, roles, enabling competencies, learning objectives, mile stones, patient encounters, forms of assessment, and quality of assessment. After 5 years of experience there will be a re-evaluation in 2020.
